Close to 500 athletes competed at the Regional Meet. Coach Mena reported more help is needed with Cross Country. While we have more teams fielding teams, the work still falls primarily to the RoadRunners. Coach Thompson indicated that he will help out in the future. He just needs to know the dates.

	 The Youth Chair noted part of the problem has been taking a summer recess break after the national meets. In retrospect, the focus needs to continue beyond the track season and next year pledges to put the focus on Cross Country beginning in late July. The National JO Meet was held December 10, 2011 in Myrtle Beach, SC. The Association was represented well, in that we had a national champion, a team champion, and runners who earned All-American designation. Maxwell Wilson of the RoadRunners was the national champion in the Bantam Boys Division. Cameron Gadalla of Millennium Express finished second in the Sub-Bantam Boys Division. The Roadrunners' Youth Girls Team placed second in their division. All Americans (Top 25) were: Maxwell Wilson, Cameron Gadalla, Ian Dickenson (BB- RoadRunners) & Christopher Depetro (MB-RoadRunners).
Meeting Date & Time	 The Youth Chair polled the members as to the preferred date, time and location of Youth Committee Meetings. Members present preferred the 3rd Tuesday of each month at 7PM. Coach Thompson offered the County Office of Education (Downtown location) as a San Diego meeting location. Members confirmed desire to hold a meeting in North County on a quarterly basis. Coach M. Mena made Orange Glen High School available. The next two meetings of the Youth Committee will be January 17, 2012 -210 Ash Street, Downtown San Diego. The Youth Committee will meet at Orange Glen High School on February 21, 2012.
2012 Track Fees	 The Chair entertained a motion regarding setting the 2012 Meet Fees. Coach Cabanas proposed by motion the 2012 fees would be \$5 per event with a minimum of \$4 per event, which was seconded by Coach M. Mena. After discussion the motion was amended by the same to have a maximum cap of \$5 per event. The motion failed to gather sufficient support to pass with Coaches Thompson, Adkins, and M. Mena voting in opposition. The Youth Chair reported the 2011 fees would be the fee schedule for 2012. \$3 per event for a 2 day meet with automatic timing \$7 per athlete for a 1 day meet with automatic timing \$1.50 per event for an All Comer's or hand-timed.

He is open to having the Youth Committee play a greater role in the event. The Youth Chair noted additional teams desirous of hosting a USATF sanctioned meet may still do so after this meeting. Coaches Thompson and Cabanas contemplated hosting meets. They will confirm at the next meeting. This agenda item will also be discussed next month. The Chair will email the local schedule which will include all USATF sanctioned meets.
